Registration fees are the sole responsibility of the buyer.

All deposits are non-refundable, but may be applied to a future litter for up to 12 months, providing your kitten pick is less than 12 weeks of age when you make this decision to switch.

Deposits must be in the form of cash, postal money order, or we can accept your credit card payment through PayPal. No charge backs will be honored through PayPal for any reason. We are sorry but NO personal checks can be accepted. Balances/final payments must be paid in cash at time of pick-up or by money order or cashier's check 7 days prior to shipping date if kitten is being shipped.

Kittens MAY be shipped after 10 weeks of age, but it is at the seller's discretion not to ship until the kitten is deemed healthy, strong and properly weaned.

Snowy Hollow Siberian Cat kittens will come to you with all age appropriate vaccinations and wormings. To the best of the seller's knowledge and belief, this kitten is in good health and free from any symptoms of contagious and infectious diseases at the time of sale. In addition, Snowy Hollow Siberian Cats also guarantees kitten to be free from genetic defects that are detrimental to the kitten's health for two (2) years from the kitten's date of birth. No further guarantee is made or implied.

In the event that a genetic defect is found by a licensed Veterinarian within the health guarantee period, Snowy Hollow Siberian Cats will replace the kitten with another kitten of equal value and sex upon receipt of letters confirming diagnosis by 2 licensed Veterinarians, and the return of the original kitten at the buyer's expense. We cannot predict a time frame when a replacement kitten will be made available, but buyer will have first pick behind the breeder and any prior

deposits already placed from subsequent litters. Snowy Hollow Siberians is NOT responsible for any vet bills incurred and will not be reimbursed. Any and all vet bills are sole responsibility of the buyer.

Warranty does not cover any diseases for which vaccinations, wormings or routine medications could prevent.

Buyer will incur all charges for vaccinations, worming, and all office exams and treatments upon purchase.

All warranties are void in the event that buyer neglects to have kitten properly vaccinated by a licensed Veterinarian, or in any way harms, neglects, or fails to give kitten proper medical attention. Buyer agrees to not declaw said kitten.

Kitten must be vet checked within 3 business days of receipt or warranty is void.

Snowy Hollow Siberian Cats will assume no shipping costs associated with sale or replacement warranty. Shipping charges are extra and not included in the price of the kitten.

Kittens that are sold as pets are to be spayed or neutered by 6 months of age. Limited Registration application papers that are being offered will be released after proof of spay or neuter from a licensed Veterinarian has been received unless kitten was sold with no papers offered.

If proof of spay or neuter is not received by 7 months of age this guarantee/warranty is considered null and void. _____Initials

Kittens sold with breeding rights may NOT be transferred to anyone other than the original buyer. Snowy Hollow Siberians reserves the first right of refusal on any kitten purchased with full reg. if buyer should chose to place said kitten.

While no refunds will be given, Snowy Hollow Siberians is willing to take back the kitten at any time if the buyer is unable to keep him/her due to any circumstances. Under no circumstances is this kitten to be sold, leased, or given away to a pet store, laboratory, research facility or animal shelter.

No guarantee is made in regards to fertility or breeding ability. All of our kitten are sold as pet quality. Some may have show potential but are not sold as such.

Snowy Hollow Siberians has the right to refuse sale and refund monies or deposits if we feel it is in the best interest of the kitten.

Snowy Hollow Siberians reserves the right to first pick of any litter.

No other guarantee is made or implied, except as stated in this written guarantee.

Any disputes will be litigated in McHenry County, IL at the buyer's expense.

Warranty applies to the original buyer only, and is not transferable. Breeding rights are also NOT transferable.
